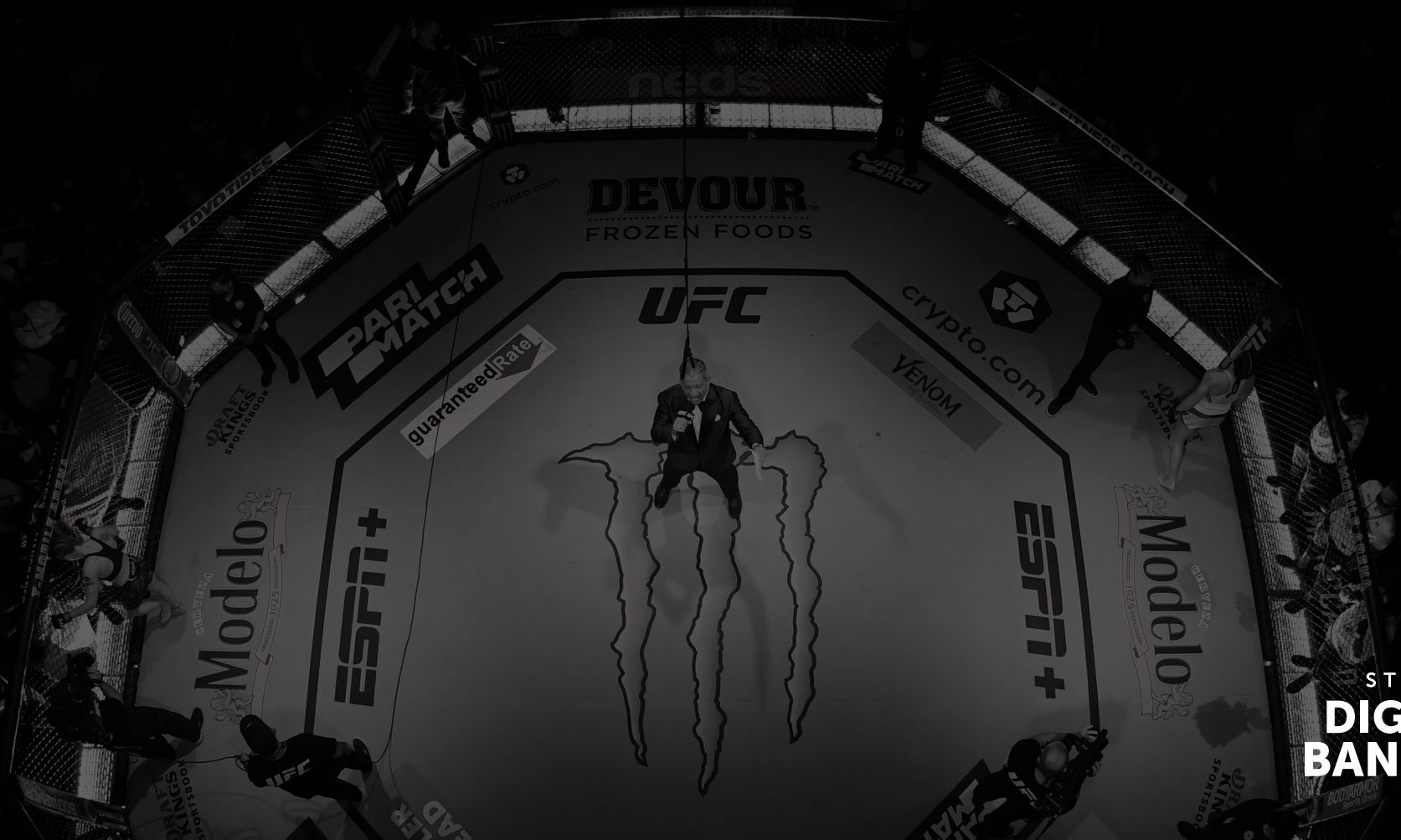

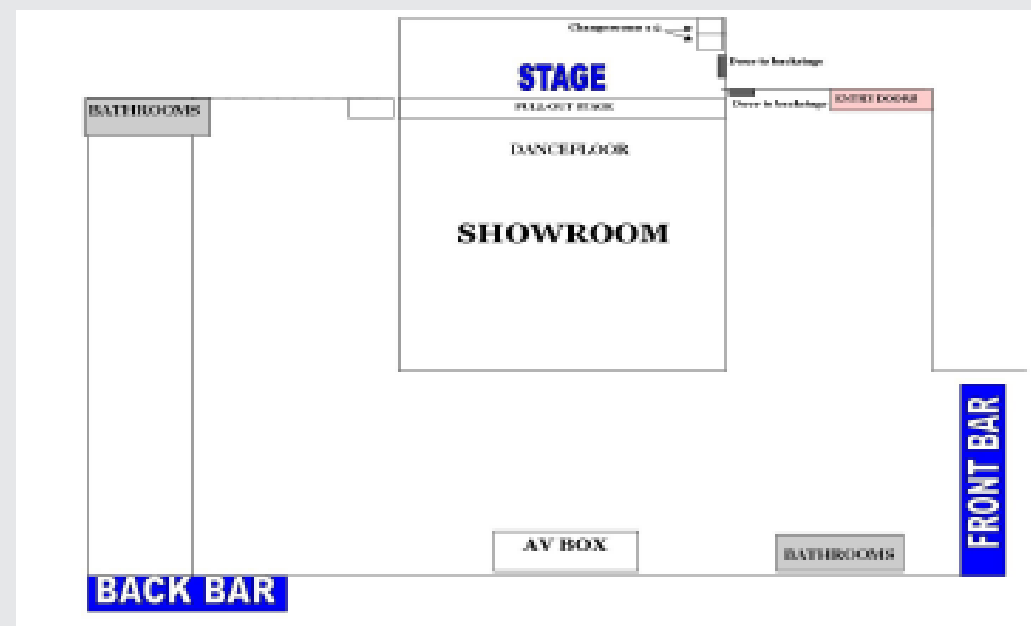

TERMS & CONDITIONS

1. Confirmation

Confirmation of your booking must be made in writing together with the requested deposit within fourteen (14) days of making the reservation. An estimated number of attendees will be given at the time of the reservation made. In this context it should be noted that when the number of attendees drops by 10% or more from the original number booked, additional charges may be incurred. Tentative bookings will only be held for two (2) weeks, should a deposit not be paid within the two (2) week period the function room will immediately be released.

2. Prices are inclusive of GST.

3. Minimum Number & Public Holiday Charges

For catering purposes, minimum number required is 50. Events held on a public holiday will incur a surcharge of 20% on total cost of Fight Event Package, or should each element be booked separately, 20% will be charged on catering and room hire.

4. The Patron

The person signing these terms and conditions will be referred to as the "Patron". The patron must be a member of the club. All persons attending the event must either be a member, be a guest of a member, or be able to produce photo identification should they live outside a 5 kilometre radius of St Marys Band Club.

5. Deposit

A Deposit of \$500 is required to secure the booking on confirmation of the booking. A booking is not confirmed or secured until such time as the deposit has been received by St Marys Band Club.

6. Start and Finish Times

The patron agrees to begin the event at the scheduled time and agrees to have the guests and other persons vacate the designated event space at the agreed completion time. The Bar will close 15 minutes prior to stated finishing time.

7. Food and Beverage

The Club offers a delightful range of appealing menus to suit any occasion and is fully licensed. The Club's policy does not allow for food or beverages to be brought

onto or taken off the premises for consumption. Menus are subject to change according to seasonal product availability. Please advise your Events Coordinator of guest food allergies upon confirming your final guest numbers and while our Catering Staff are extremely vigilant in ensuring that the offending allergen is not in the meals prepared, this cannot be guaranteed as a wide variety of ingredients are used in the kitchen on a daily basis.

8. Labour

Labour charge is applicable for events extending after the 5 hour period at \$150 per hour or part thereof. During this time, drinks will be charged on a consumption basis or cash Bar and payment will be finalised on completion of the event.

9. Insurance

The Club will not accept responsibility for damage or loss of merchandise left in the Club prior, during or after functions. Organisers should arrange insurance at all times for their own benefit.

10. Damage to Club Property

Organisers are financially responsible for any damage sustained to Club property

during functions / exhibitions

11. Cancellation

If your function is cancelled, the following conditions apply:

Notice of 6 to 9 months:

Your full deposit will be refunded, provided the room is subsequently re-booked. No cancellation fee will be incurred.

Notice of 4 to 6 months: A cancellation fee of 10% of the total projected revenue will be incurred unless the room is subsequently re-sold. Deposits will not be refunded.

Notice of less than 4 months:

A cancellation fee of 15% of the total projected revenue will be incurred and your deposit retained. In the event of any form of entertainment or service having been booked by the club for the function, the full charge for these services may be incurred.

TERMS & CONDITIONS

12. Change of Date

Change of date made 9 months or more before the function date can be confirmed with the original being transferred to the new date. Change of date made within 9 months of the function date requires a further deposit and the same terms apply as for a cancellation. Change of dates must be received in writing.

The St Marys District Band Club reserves the right to change your room should reasonable circumstances arise; for example a decrease in numbers.

13. Gifts

We will endeavour to take care of gifts delivered to the St Marys District Band Club, but accept no responsibility or liability. We request that you appoint someone to deliver your gifts to your desired destination after your function. No gifts are to be left on the premises after the function please.

14. Price Variation

Every endeavour is made to maintain prices as printed, but packages are subject to an

increase to meet rising costs.

15. Advise of Final Numbers and Details

Reconfirmation of the number of guests attending and all final details should be notified to the Functions Department 14 days prior to the event. A guaranteed minimum number must be advised 7 working days prior and will confirm the minimum numbers to be billed.

16. Final Payment

The final account is due and payable 14 working days prior to your function. This payment is to be made by cash, credit card, direct deposit or bank cheque only.

17. Policing

For the protection of patrons paid police will be required for the duration of the event with the cost, to be covered by the organiser. In accordance with our Liquor Awareness Policy, we reserve the right to refuse supply of liquor if we feel the patron or guest appears to have over consumed.

18. Dress

All guests must conform to the Club's dress regulations of neat, clean and tidy dress; the

Club reserves the right to refuse entry.

19. Responsible Service Of Alcohol

While our VIP Catering Packages include continuous beverage service for the entirety of your event, the club reserves the right to refuse service of alcohol to any person who shows signs of intoxication as per the club's responsible service of alcohol policy. In addition any person who is violent, quarrelsome, disorderly or intoxicated shall be removed from the premises of the Club and no refund will be given if this occurs.

Please Note: No shots or doubles will be given and yard glasses are not permitted at functions.

20. Booking Agreement

TERMS & CONDITIONS

Responsible Service Of Alcohol Policy

Liquor Act 1982 and Registered Club Act 1976 – any person who sells or supplies liquor to an intoxicated person or licensed premises is guilty of an offence. Penalties do apply.

The Bandy Limited promotes a policy of Responsible Service of Alcohol. The Club recognises that it our obligation not to serve any customer to intoxication and also not to serve or supply alcohol to any customer under the age of 18 years. Private functions being held within the Club are no exception to this policy.

The Club will not allow intoxicated, disruptive or violent behaviour to occur on the premises and will seek to ensure that no harm comes to patrons as a result of our service of alcohol.

The Club will not serve the following at any time:

- No shots
- No doubles

Liquor Act 1982 and Registered Club Act 1976 – If you are drunk, disorderly or violent on these premises we will ask you to leave. If you fail to leave when you are asked you are committing an offence – there is an on the spot fine and maximum court fine.

In the event that a guest is removed from your function (or the Club) the laws in relation to Responsible Alcohol clear-ly state the following:

“You are required by law to move more than 50 metres away from our premises. You CANNOT return to our venue for at least 24 hours. You are NOT permitted to re-enter the vicinity within 6 hours.

If you fail to comply, you commit an offence and police may take action.”

Should there be an incident where the Responsible Service of Alcohol policy is enforced during your function, and the offender is NOT cooperative, bar service will stop until such time as that incident is resolved.

UNDERAGE DRINKING

Underage patrons attending your function must adhere to the Club's policies by only entering those areas in which children are permitted. The conduct of children is the responsibility of the accompanying adult at all times.

St Marys Band Club Limited has procedures designed to detect underage patrons seeking to enter the premises. If a staff member believes that a patron who is ordering, or being supplied alcohol is under 18 years of age they will request to see the appropriate photo identification for proof of age:

Accepted appropriate identification is as follows (as stated by licensing laws):

- Passport
- NSW Photo Card
- Photo Driver's Licence

If the patron is less than 18 years of age, or fails to produce identification, the patron will be refused the service of alcohol and will be removed from a restricted area.
